




Installation

Install the Driver

- 1. Navigate to www.startech.com/1P3FPC-USB-SERIAL
- 2. Click the **Drivers/Downloads** tab.
- 3. Under **Driver(s)**, download the **Driver Package** for your operating system.

Windows

- 1. Right-click the downloaded file and extract the contents with **Extract All**.
- 2. Browse the Windows folder and run the **Setup** file.
- 3. Follow the on-screen instructions to complete the installation.
- 4. Connect the **USB to Serial Adapter Cable** to an available USB port.

macOS

- 1. Double-click the downloaded file.
- Open the folder that matches your macOS Version and run the Setup file inside the folder.
- 3. Follow the on-screen instructions to complete the installation.
- 4. Connect the **USB to Serial Adapter Cable** to an available USB port.

Verify Driver Installation (Windows)

- 1. Navigate to the **Device Manager**.
- 2. Under Ports (COM & LPT), right-click Prolific USB-to-Serial Comm Port and click Properties.

3. Confirm that the **Driver** is installed and working as expected.

macOS

- 1. Navigate to **System Information**.
- 2. Expand the **Hardware** section and click **USB**.
- 3. Confirm that **Prolific USB-to-Serial Comm Port** appears in the list.
