

## BS8599-1 Compliant vs. HSE First Aid Kits

## What is the difference in legislation?

Although workplaces have changed in the past decade, the standard guidance on first aid kits under the Health & Safety Executive Regulations (HSE) has remained static since 1981. The HSE provides some guidance on the type of items that should be in a first aid kit, but not the quantities. With no changes in regulation since 1981, it was evident that a new standard needed to be implemented.

BS8599-1 compliant kits have been improved to meet current hazards and risks. They take into account development of innovative modern products and updated first aid practices. The BS8599-1 compliant kits provide a simple method for employers to choose a kit that matches their risk assessment and demonstrate compliance with the law.

## What's the difference between the contents?

#### **ADHESIVE TAPE**

BS8599-1 compliant kits include adhesive tape, to give First Aiders the choice between tape or safety pins to secure bandages.

#### **BURN DRESSINGS**

As most workplaces include a risk of burns, BS8599-1 compliant kits include a burn dressing, together with a conforming bandage to attach and hold the dressing in place.

#### **CLEANSING WIPES**

BS8599-1 standards require cleaning wipes to be saline wipes only, allowing for use on an open wound. HSE standard non-alcohol wipes can only be used to cleanse unbroken skin.

#### **FOIL BLANKETS**

Clinical shock presents one of the most life-threatening risks to a casualty. The introduction of heat-reflecting foil blankets combat clinical shock and can be used to keep casualties warm.

#### **FINGER DRESSINGS**

Finger dressings have been introduced for finger injuries that are too large for plasters.

#### **GLOVES**

The BS8599-1 standards require disposable gloves to be nitrile. These are latex-free, and superior in terms of protection, comfort, and sensitivity. They also conform to BS EN 455-1 and BS EN 455-2 standards.

#### **RESUSCITATION SHIELD**

BS8599-1 compliant kits have introduced a resuscitation shield which includes a one-way valve, protecting the first aider from infection.



### The HSE states:

"Employers may wish to refer to British Standard BS8599 which provides further information on the contents of workplace first aid kits."

#### **SHEARS**

Shears have been introduced to BS8599-1 compliant kits, allowing clothing to be cut away for more effective first aid treatment.

#### TRIANGULAR BANDAGES

Quantities of triangular bandages have been reduced to reflect changes in training protocol, as they are no longer used for immobilisation of lower limbs.

#### WASHPROOF PLASTERS

In BS8599-1 compliant first aid kits, the quantities of plasters have been increased to reflect consumer demand.
