4. PHYSICAL AND SAFETY DATA

Rollerball with water-based ink, four writing colours, excellent cap-off time, line width 0.5 mm. Casing (shaft) and cap with metal clip are made of polypropylene resp. thermoplastic elastomer. Ergonomic soft grip zone for optimum grip covers the hole pen for relaxed and comfortable writing. Free-ink reservoir and pressure-compensation system.

When stored and used properly, no hazardous reactions can be expected. In case of fire, carbon monoxide (CO), carbon dioxide (CO₂) and with some colours nitric oxides (NO_x) will be set free as thermal decomposition products.

When not used properly, some colours may stain the skin, mucous membranes or clothing and fabrics. In some materials, the stain might be permanent.

In case of contact with the eyes, rinse out open eye thoroughly under running water for several minutes. If complaints persist, contact an ophthalmologist.

They are, however, very durableon account of their intended use and therefore biodegradability in normal conditions in sewage works or in surface waters is difficult. They can, however, be sufficiently adsorbed in the activated sludge and eliminated from the water.
