### 2.3. Other hazards

Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. The classification of the mixture is based on the individuel ingredients and their concentration within the mixture.  
All ingredients contributing to the classification are stated in Section 3 of the SDS.  
Relevant limit values of ingredients on which the exposure assessment is based, are listed in section 8 of the SDS.  
The product may contain sensitizing ingredients that may cause allergic reaction to certain people.  
Section 2 of the SDS states these ingredients where applicable.
